



TAXES ON RSA BENEFITS

Form 1099-R for use in filing an income tax return. The 1099-R reports the amount of retirement benefits subject to federal income tax. More information is available on RSA's website at www.rsa-al.gov. If you have not received your 1099-R form, please call

In January, the RSA provides retirees

RSA retirement benefits are not subject to state of Alabama income tax if you reside in Alabama. If you reside in another state, contact that state's revenue department to determine whether retirement benefits are taxable in that state or visit www.irs.gov.

877-517-0020 to request a duplicate form.

Your retirement benefit is subject to federal income taxation. However, contributions to the RSA that were previously taxed and/or purchases of service credit with previously taxed funds are exempt from federal taxation.

If you have questions about your taxes, we suggest you consult your accredited tax professional or financial advisor. Also, many senior centers across the state host free tax preparation services specifically for seniors. The President-Elect serves a one-year term followed by terms as President and Immediate Past President while the Secretary-Treasurer serves a three-year term. FOR COUNTY COMMISSION RACES

At the same time that Alabama holds its March 5th presidential primary election, voters will also cast ballots in several county commission races across the state.

As one of the few groups that make contributions to local government candidates, ARSEA/APEAL's Friends of Retirees and Employees Political Action Committee (FOREPAC) is among our most effective tools for electing local officials who understand and support the issues that are important to our members.

Since its creation, FOREPAC has worked to increase ARSEA/APEAL's influence by supporting candidates who understand **first-hand** the importance of **our retirement benefits and the Retirement Systems of Alabama**.

FOREPAC has also helped us elect several dues paying ARSEA/APEAL members to political offices across the state, which is important because they share the same economic and political concerns that our association focuses upon.

Electing fellow ARSEA/APEAL members ensures that they will continually promote the mission of our association to protect and improve our retirement benefits.

If you are a member of FOREPAC, we invite you to send us the names of candidates you feel deserve our endorsement. We will share your recommendations with our FOREPAC District Advisory Chairs (DACs), and once the FOREPAC Board ratifies the recommendation, we will present a campaign contribution to the candidate.

CONTACT YOUR LEGISLATORS

Ask your Lawmakers to support COLA Legislation

The 2024 regular session of the Alabama Legislature is quickly approaching, and ARSEA/APEAL has been working hard on behalf of our retiree COLA before lawmakers convene.

While our staff works at the Alabama State House to convince legislators to embrace a retiree COLA this year, nothing is as effective or influential as contacts from voters back home, which is why your involvement is essential.

We encourage you to ask your lawmakers to support ARSEA/APEAL's retiree COLA legislation. Your phone calls, emails, letters, and other legislative contacts remain necessary for our efforts to be successful.

Points to make when discussing the Retiree COLA:

- Explain to your legislators that retirees have not received a COLA for 18 years and inflation continues to dramatically reduce the value of your retirement dollars.
- Outline any financial struggles or difficult decisions you have faced due to rising prices and stagnant benefits.
- Our legislation does not harm the finances of the Retirement Systems of Alabama, nor does it add one penny to RSA's unfunded liability.
- The legislation allows cities, counties and local public boards participating in RSA the option of awarding retiree COLAs.
- The measure treats COLAs as a pay-as-you-go option in state and local government budgets and can be paused during years in which finances lack adequate funding.
- The legislation will require the annual cost of the COLA to be paid in full each year, making the retiree COLA an annual budget consideration, remaining at the full control of the Alabama Legislature and participating local governments.
- The cost of this COLA decreases every year as retirees pass away. It would be the only budget item that declines each year.

We believe this push for retiree COLA legislation is the most intensive and important lobbying effort in our 44year history. If we are successful, bonuses will soon be replaced with recurring COLAs, but it can only happen with your full participation.

LOTTERY AND GAMING LEGISLATION INCLUDES STATE RETIREE BENEFIT FUNDING SOURCE

When the 2024 regular legislative session convenes, lawmakers will debate and vote upon a proposed constitutional amendment that creates a state lottery and authorizes casino gaming and sports betting at various locations across Alabama.

The legislation, which is being sponsored by State Rep. Andy Whitt (R - Harvest) and Rep. Chris Blackshear (R - Phenix City), also allows casino revenues to fund "retiree bonuses," or, when the ARSEA/APEAL costof-living adjustment measure passes, retiree COLAs.

Proceeds from a state lottery, which would include multi-state games, such as Powerball, Mega Millions, and also offer scratch-off instant winner tickets, are estimated to total \$200 to \$300 million annually and would be earmarked for the Education Trust Fund.

Casino and sports betting revenues, predicted to be in the \$300 to \$400 million range, would be directed to the General Fund budget. All casino locations could offer both electronic devices, such as slot machines and video poker, and table games, which include craps and blackjack. Sports betting would also be offered at all casino locations as well as online.

An Alabama Gaming Commission created by the measure would oversee and regulate all legal operations within the state and close non-sanctioned, illegal gambling activity that takes place.

ARSEA/APEAL supports the gaming amendment because it provides a dependable and dedicated funding source for future state retiree increases.

In addition, we have always taken the general position that Alabamians should be allowed to express their views on matters of great importance, such as the creation of a state lottery and the authorization of gaming, though a statewide referendum election, which the constitutional amendment would require.

At key points during the session, we will ask members in our Weekly Update emails to contact legislators and ask them to support the gaming amendment.


2024 LEGISLATIVE ROSTER



ATTENTION STATE RETIRES 2023 PART D SURCHARGE REIMBURSEMENT

State retirees with Medicare Advantage coverage may be eligible for an insurance reimbursement from the State Employees Insurance Board.

If you had Part D Income Related Monthly Adjustment Amount (IRMAA) surcharges deducted from your 2023 Social Security payments, SEIB will reimburse you for the amount of the monthly surcharges you were required to pay last year. Please note that Part B Premiums or the IRMAA related to Part B are not eligible for reimbursement.

To determine if you are eligible for the Part D surcharge reimbursement, refer to the chart below. To request a reimbursement, you must submit a copy of your Social Security statement showing the 2023 Part D premium amount that was deducted from your Social Security income last year. Email this information to accounting@ alseib.org or send it by mail to: SEIB, Attn: Accounting, P.O. Box 304900, Montgomery, Alabama 36130-4900.

WHAT IS IRMAA

The income-related monthly adjustment amount, or IRMAA is a surcharge that people with income above a certain amount are required to pay in addition to their Medicare Part B and Part D premiums. The Medicare IRMAA for Part B went into effect in 2007, while the IRMAA for Part D was implemented as part of the Affordable Care Act in 2011.

The Social Security Administration (SSA) determines who pays an IRMAA based on the income reported two years prior. So, for 2024, the SSA looks at your 2022 tax returns to see if you must pay an IRMAA. IRMAA is calculated every year. That means if your income is higher or lower year after year, your IRMAA status can change. If the SSA determines you must pay an IRMAA, you'll receive a notice with the new premium amount and the reason for their determination. However, if you have had a life-changing event that has changed your income such as marriage, divorce, death of a spouse, or retirement, you can request a new assessment using a Medicare IRMAA Life Changing Event Form.
